ADVERTISEMENT FOR GUEST/PART-TIME TEACHERS

Applications are invited for preparing a panel of eligible candidates of Guest / Part-Time Teachers in different subjects at the University P.G. Departments. The detailed educational qualifications, eligibility criteria, submission of the application form and other information will be made available at the official website of the University from 04.10.2021. The last date for submission of the Application Form in the office of the Registrar is 18.10.2021 at 05:00 pm along with a Demand Draft of Rs.500/- in favour of The Registrar, MMHA&PU, Patna. The application format for Guest Teachers may be downloaded from the University Website.

INSTRUCTIONS FOR APPLICATIONS FOR GUEST TEACHERS/PART-TIME TEACHERS

1. Applications are invited from those fulfilling the eligibility criteria as mentioned below for engagement of Guest/Part-Time teachers at the University P.G. Department of Maulana Mazharul Haque Arabic & Persian University, Patna in the following subjects:-

Note:-(i) The number of vacant posts may increase or decrease at the time of engagement.

- (ii) The university may engage teachers from the panel so prepared. The engagement shall be for eleven months or till the regular appointment of the teacher, whichever is earlier.

2. Essential Qualification and Experience:-

- (i) A candidate should have secured minimum 55 percent marks at the Master's degree or equivalent (or equivalent grade) level. Relaxation of 5 percent marks will be given at Master's Level.
(a) for SC/ST candidates of the state.

Or

- (b) for physically challenged persons from any part of the country but both benefits shall not be admissible to the same candidate.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) Conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET however the candidate who has been awarded Ph.D. Degree in accordance with the University Grants Commission (Minimum Standard and Procedure Regulations, 2009) shall also be exempted from the requirement of passing the NET/SLET/SET subject to the fulfillment of following conditions.
- (a) The Ph.D. degree of the candidate has been awarded in regular mode.
- (b) Evaluation of the Ph.D. thesis by at least two external examiners.
- (c) The candidate had published two research papers out of which at least one is published in a referred journal from out of his/her Ph.D. work.
- (d) The candidate had presented two papers in seminars/conferences out of his/her Ph.D. work.
- (e) Open Ph.D. viva voce of the candidate had been conducted.

Point (a) to (e) as above are to be certified by the Dean of the respective faculties.

- (iii) NET/SLET/SET shall also not be required for such Master Programmes in which NET/SLET/SET is not conducted.

3. Terms & Conditions:-

- (i) The above number of requirements in different subjects is provisional and subject to variation. The University reserves the right to vary the requirements including reserved requirements.
- (ii) The current Reservation Policy of the Government of Bihar will strictly be followed.

- (iii) Age, experience and all other prescribed qualifications will be counted as on 30th November, 2018. The Minimum age requirement is 23 years and a maximum of 55 years.
- (iv) The engagement will in no circumstances be linked to regular appointments and may not be regularized at any stage.
- (v) The honorarium will be consolidated in nature at the rate of Rs.1500/- per class with a maximum of Rs.50,000/- per month.
- (vi) The engagement can be terminated by the competent authority at any time without assigning any reason thereof.
- (vii) The selected persons shall not be entitled to any other benefit like Provident Fund, Pension, Gratuity, Medical Treatment, Seniority, Promotion etc. or any other benefits available to the University Teachers appointed on regular basis.
- (viii) The selected Guest / Part Time teachers shall not be entitled to avail any allowances / facilities being extended to the regular / permanent faculty members of the University.
- (ix) The candidate should not have been convicted by any Court of Law.
- (x) In case any information is given or declaration made by the candidate is found to be false or if the candidate has willfully suppressed any material information relevant to this employment, he/she will be liable to be removed from the engagement and proper action can be taken as deemed fit by the university authority.
- (xi) The competent University Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part thereto without assigning any reason or giving notice.
- (xii) The candidates are required to submit Application along with self attested copies of all the relevant certificates so as to reach the office of the Registrar, Maulana Maulana Mazharul Haque Arabic & Persian University, Patna, Mithapur Farm Area, Mithapur, Patna-800001 through hand/registered post/courier only latest by 18.10.2021 till 05:00 pm.
- (xiii) **Candidates are required to attach a self-addressed envelope (Size:16*10cm) along with the Application form. Stamp of Rs.40/- must be affixed on the envelope.**
This will be used to intimate shortlisted candidate only the date, time and place of interview to be decided by the University.

They are further advised that before submitting the application form they must have gone through carefully the details of conditions and instructions published with this Advertisement.

Incomplete applications without requisite eligibility criteria and documents will be summarily rejected.

4. **Selection Process:-** Educational Qualification shall carry 85 marks and Interview shall carry 15 marks. The distribution of marks for academic career will be same as provided in the statue approved by the Hon'ble Chancellor communicated vide No.BSU-25/2014-1359/GS(1) dated 11.09.2014.

However, candidates will be given the benefit of Ph. D./M. Phil. Degree. But the candidate will be entitled to claim the benefit of either M. Phil or Ph.D. but not for both.

Conversion formula laid down by the degree awarding University /Institutions concerned.

In the event of total marks obtained from educational qualifications and interview being the same, candidates having higher marks in educational qualification will be placed higher in the final merit list. If the candidates who are elder in age according to the date of birth will be placed higher in the final merit list and in the event of candidate having the same date of birth, candidates whose name appear alphabetically first in Devenagri Script will be placed higher in the final merit list.
