WHEREAS, Chanakya Foundation, Vill-Chhitampur, Street/Road-Chanakya Nagar, Taluka/ Mandal-Koilwar, Town/City-Chhitampur, Dist-Bhojpur, Bihar-802160 (Code No. ERCAPP201646142) (ID. No.9858) was granted recognition for B.Ed. course with an intake of 100 (Two basic Units) from the academic session 2017-2018 vide ERC order dated 02.05.2017.

- 2. AND WHEREAS, Withdrawal order under section 17(1) of NCTE Act, 1993 was issued vide No.61335 dt.22.08.2019 to the institution withdrawing recognition from the academic session 2020-2021 as per decision of ERC taken in 275th meeting held on 27th July, 2019 for non-compliance to the Show Cause Notice issued vide letter dt.08.02.2019 on the following deficiencies:
 - i. Approved faculty list by the concerned affiliating body along with requisite documents.
 - ii. Approved building plan by the concerned competent Govt. Engineer/Authority.
 - iii. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
 - iv. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - v. Confirmation on website updates of the institutions with all details along with affidavit.
 - vi. Fire safety certificate issued from the competent Govt. Authority.
- 3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the withdrawal order of ERC and the Appellate Authority vide order No.89-433/E-140144/2019 Appeal/1st Mtg.-2020/ 29th January, 2020/ 89093 dt.17.02.2020 remanded back the case to ERC on receiving a due reply to the Show Cause Notice with supporting evidences. ERC is required to revisit the matter for issuing and appropriate order afresh.
- 4. AND WHEREAS, on the direction of Appellate Authority, institution submitted reply dt.24.02.2020 received on 28.02.2020.
- 5. AND WHEREAS, the ERC in its 280th meeting held on 29th February & 01st March, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 23.12.2019 and decided as under:-

Restoration of recognition order of B.Ed. course to be issued.

5. NOW THEREFORE, recognition withdrawn vide order No.61335 dated 22.08.2019 to the institution viz. Chanakya Foundation, Vill-Chhitampur, Street/Road-Chanakya Nagar, Taluka/ Mandal-Koilwar, Town/City-Chhitampur, Dist-Bhojpur, Bihar-802160 (Code No. ERCAPP201646142) (ID. No.9858) for B.Ed. course is hereby restored.
