Notification

No. 2/P. 5-11/2005 H.E. 1551/ In exercise of the power conferred under proviso of section 3 (1), the Bihar State University Act 1976 (Bihar Act 23, 1976) as amended up to date, the state government is hereby pleased to notify the following function of the Maulana Mazharul Haque Arabic and Persian University subject to other provisions of the Bihar State University Act and statutes framed under the provision of this Act:-

- (i) to confer or grant degree, diploma, certificate and other academic distinction in Arabic or Persian or in such other branches of learning, including vocational, professional and education, as the University may consider fit.
- (ii) to organise examination and to confer degree, diploma and certificate and other academic distinction to such persons who fulfill the conditions as specified in regulations approved by the Chancellor.
- (iii) to organise examination other than examinations referred to in clause (ii) considered fit or directed by the State Government and grant equivalence by the University; to prescribe courses of study and frame regulation thereof, and to grant certificates, diploma or degree on the basis of examinations result thereof;
- (iv) to undertake academic work and research to promote the objectives of University and to prepare and approve panel of teachers for conducting academic & research work from other Universities or institutions of Bihar till is created in the University and to recognise teachers as qualified to give instruction in Colleges institutions;
- (v) to centralise the conduct of undergraduate teaching in or subjects at one or more centres with a particular standard and where the University decides to centralise the conduct of such undergraduate teaching, it shall be lawful for the University to arrange and provide for centralised delivery of lectures through knowledge Resource Centre Network in such subject or subjects at its head quarters or designated centres and to utilise physical and staff facility of one or more Colleges or institutions as may be prescribed for that purpose;
- (vi) provided that until appointments to teaching posts are made, the seats specified in clauses (f) (g) and (h) under section 22 of syndicate and (3), (5), (6) under section 24 of Academic Council, in the Bihar State University Act (1976), the Chancellor shall depute such number of teachers, not below the rank of Professor from other Universities in the State as he may think fit.

If any time it is found that function mentioned above is contrary to the provisions of the Bihar State University Act 1976 and statutes then later shall prevail in all the activities of the university.
