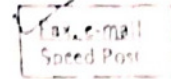

Sub:- Proposal of the State Government for making amendment in the Statute approved vide letter No-BSU-16/86-1098/GS(I) dated 19-04-1986 regarding requirement of the land for governing the affiliation of Colleges of Bihar in view of the guidelines of UGC.

Sir,

I am directed to invite a reference to the subject noted above. This is to inform that Hon'ble Chancellor after due consideration of the proposal received from the Education Department, Government of Bihar vide letter No.-14/M 7-56/14-1036, dated 06-07-2015 and considering the opinion of different Vice Chancellors on the Draft Statute submitted by three Vice Chancellors' Committee, has been pleased to approve the proposal of the State Government for making amendment in the Statute approved vide letter No-BSU-16/86-1098/GS(I), dated 19-04-1986 regarding requirement of the land for governing the affiliation of Colleges of Bihar in view of the guidelines of U.G.C. Hon'ble Chancellor in exercise of the powers conferred upon him under section 36 (7) of the Bihar State Universities Act, 1976 as amended upto date, is pleased to incorporate following amendments in the Statute:-

- 1) In Patna urban area, the undisputed ownership and possession of land measuring not less than 2 acres for establishing educational Institutions.
- 2) In other urban areas, the undisputed ownership and possession of land measuring not less than 2.5 acres for establishing educational Institutions.
- 3) In other rural areas, the undisputed ownership and possession of land measuring not less than 5 acres for establishing educational Institutions.
- 4) No Colleges shall take admission of any student without prior affiliation and approval of the State Government. The provision of Section-21 (2) (d) proviso of Bihar State Universities Act, 1976 shall be taken as mandatory.

Accordingly Provision 3 (f) of Statute relating to Administration and Exclusion of Colleges other than those managed and maintained by the University approved vide letter No BSU 16/36 1098/GS(I) dated 19.07.1986 is amended. Now Section 3 (f) will be read as "That the institution owns and possesses at least 05 acres of land for the College buildings, hostels, quarter and playgrounds if situated in rural areas or 2.5 acres in other urban areas and 2 acres in Patna urban area in not
